Mumbai resident suffers miscarriage due to Covid

AFIRST trimester mis-carriage in a Mumbai resident is being linked to the SARS-CoV-2 virus after tests found the infection had travelled into the umbilical cord, pla-centa and possibly caused inflammation

"To our knowledge, this is the first case demonstrating persistence of SARS-CoV-2 infection in a tissue weeks after clearance in the throat swabs... the virus not just survived in the tissue hut is replicated. tissue but is replicatissue but is replica-tive in the placental cells," stated a re-search paper submit-ted last week by the National Institute of Research in

Research in Reproductive Health (NIRRH) – a research arm of the Indian Council of Medical Research – in collabo-ration with ESIS (Employees' State Insurance Scheme)

comproyees State Insurance Scheme) hospital at Kandivali. The paper was posted on August 22 on Medikaw, an online site that publishes pre-prints of medical and scientific papers. The woman, a hospital security guard in her late twenties, tested postive for Covid-19 when she was asymptomatic. Five weeks later, when she was a symptomatic. Five weeks later, when she was in the 13th she was in the 13th week of her preg-nancy, her nasal swal nancy, her nasal swab test returned negative. But after her 13th week of pregnancy, when she went for a routine ultrasound test, the foetus was found to be dead.

Suspecting it to be linked with Covid-19, ESIS hospital approached the NIRRH to investigate further. The hospital's ethics committee approved tests on the woman.
"We first tested her nasonarynegal."

"We first tested her nasopharyngeal for Covid-19 again, and it came negative. Then we tested the placenta, amniotic fluid and foetal membrane. We were sur-prised to find that five prised to find that live weeks after she got the infection, the virus was replicating in the placenta," said Dr Deepak Modi, pla-centa biologist in NIRRH.
