Gujarat waives off 80% stamp duty on property transfers by housing societies

AFMEDABAD, JUNE 30

INA move aimed at significantly reducing financial burden on the middle class in the event of property transfer, the Gujarat government on Monday and the stamp duty payable on transfers and share certificates by societies, associations, and non-trading corporations.

The decision comes just over two months after the government hileed the penalties on unpaid dues by four to six times, which now stand relaxed for the aforementioned bodies.

In a notification issued late Monday, the government clari-

In a notification issued late Monday, the government clari-feet that the benefit of the reduc-tion would be applicable only to property transfers made "on or before" June 20, 2025, and no re-fund would be given in cases where the dues and penalties had been alterady paid before the notification was published. The decision was taken fol-lowing protests from certain quarters to the government's April announcement, stating hat penalties on unpaid duties had been hiked between four to six times on dues on property

According to Monday's deci-sion, in cases where societies, as-sociations, and non-trading cor-porations carry out property transfers through allotment let-ters or share certificates, up to 80% of the payable duty will be waived. Thus, only about 20% of the portional divide amount will be the original duty amount will be collected, a government release

collected, a government release said.

As per the notification, in cases where after applying the 80% deduction on the deficit stamp duty amount, if the resulting duty and penalty chargeable under section 39 (1) (b) of the Gujarat Stamp Act, 1958, are less than the original amount payable, "then a minimum amount equal to the original chargeable stamp duty shall be recovered from the applicant". This section outlines the procedure for impounding an instrument for not being duly stamped.

The amendment has been made under the provisions of Section 9 (a) of the Gujarat Stamp Act, 1958, which gives the government power to reduce or remit stamp duty.
In April this year, the state government had announced certain revisions to "ensure effective invalement strong feet."

By reducing the originally payable stamp duty, 'the state government ensures that the total amount paid—including any penalties—will not exceed what was earlier payable as duty alone in property-related matters', the government asid. 'The benefit of the reduction shall be applicable to those cases also which are voluntarily submitted for payment of the stamp duty or such other cases revealed during inspection, onor before the date of publication of this norification,' the document said.

Cyber 'fraud': Surat woman arrested from Delhi airport

Gurgaon: Unknown callers in-timidating victims with claims of misuse of mobile numbers or of misuse of mobile numbers or Aadhaar cards for hawala trans-actions, some fraudsters then posing as police officers to en-force a "digital arrest", and then others impersonating as Customs or Income Tax Department of Department officials to extort money through bank transfers: this is how a cyber fraud racket allegedly operated from a Cambodia-based call centre, said police. The investigation into the racket has deepened with the arrest of a 24-year-old woman from Gujarat's Surat on Sunday at the Indira Gandhi

from Gujarat's Surat on Sunday at the Indira Gandhi International Airport in Delhi. Identified as Khushboo, the accused was arrested in connec-tion with a "digital arrest" case, where fraudsters posed as po-lice, CBI and Customs officers to lice, CBI and Customs ofticers to allegedly extort money by threatening the victim with fake charges of illegal activities, said officers. So far, 16 people, includ-ing her, have been arrested in connection with the case, the

Gurgaon Police said. The investigation, led by The investigation, ieu uy Priyanshu Diwan, Assistant Commissioner of Police (Cyber Crime), revealed that Khushboo was part of a Cambodia-based call centre, allegedly involved in

The complainant told the police that her son received a call claiming his Aadhaar card was linked to hawala transac-tions. Afake CBl officer contacted tions.
